Re: A case to end the sale of reptiles and amphibians

Dear Mr. Blundell,

We, the undersigned Canadian and American animal welfare and protection organizations, conservation organizations, veterinarians and scientific experts recognize and appreciate the positive contribution PetSmart and PetSmart Canada has made toward the advancement of dog and cat welfare through the establishment of PetSmart Charities, various public education initiatives, proactive facilitation of animal adoptions and shelter support. Your efforts have helped an extraordinary number of dogs and cats across North America.

Using PetSmart's history of positive actions aimed at enhancing and protecting the welfare of companion animals as a guide, we are asking you to take an additional step to help protect the welfare of tens of thousands of additional animals, specifically the reptiles and amphibians, that have, until recently, received relatively little attention.

Based on an ever-increasing body of science regarding the cognitive, emotional and social capabilities of reptiles and amphibians, the important ecological roles they play in nature, the public health risk they can pose and rapidly changing public sensibilities, we believe that ending their sale would be a positive step for animals, the environment and for PetSmart as well.

While we would like to see a broad-based re-evaluation regarding the keeping of all wild animals as pets, ending the sale of reptiles and amphibians would be an important first step in that process. Doing so would result in:

- Reducing financial and human resource pressures on shelters and rescue centers.
- Protecting tens of thousands of animals annually through the prevention of impulse purchases.
- Alignment with the 90% of your Canadian customers who do not believe that reptiles and amphibians make appropriate pets, including the 81% who would be willing to start shopping elsewhere out of concern for animal welfare.
- Preparedness for a growing political interest to curb the wildlife trade, including the exotic pet trade.
- Showing your customers that PetSmart and PetSmart Canada is progressive, ethical and places the best interest of the animals as a primary consideration, something that should increase customer loyalty and establish PetSmart as the industry leader.

In conclusion, we would like to say that should PetSmart move to protect the welfare and conservation of reptiles and amphibians, that decision would be celebrated by Canadians and Americans from coast to coast, your customers and the entire animal welfare and protection sector. We look forward to supporting you on such an initiative.
